**Action:** Notice of Public Hearing to Consider the Adoption of an Amendment to Chapter 290-1-8 related to Authorizing Consumer Reports for Foster Care Youth.

**To All Interested Persons and Parties:**

Pursuant to the Official Code of Georgia Annotated, O.C.G.A. §§ 4-4-2 and 4-4-83, notice is hereby given that the Georgia Department of Human Services, Division of Family and Children Services will be considering the adoption of an amendment to 290-1-8 related to Authorizing Consumer Reports for Foster Care Youth. The proposed amendment affects chapter section 290-1-8-.02 The Department will be accepting written comments from July 9, 2015, to close of business (4:30 p.m. EDT) on August 10, 2015.

A public hearing is scheduled to begin at 1:00 p.m. on August 12, 2015, at the Board Room on the 29<sup>th</sup> floor of 2 Peachtree Street to provide the public an opportunity to comment upon and provide input into the proposed amended rule. At the public hearing

anyone may present data, make a statement, comment or offer a viewpoint or argument whether orally or in writing. Lengthy statements or statements of a considerable technical or economic nature, as well as previously recorded messages, must be submitted for the official record. Oral statements should be concise and will be limited to 5 minutes per person. Additional comments should be presented in writing. Written comments are welcome. To ensure their consideration, written comments must be received on or before August 10, 2015. The proposed amended rule will be considered for adoption by the Board at its meeting scheduled to begin at 1:00 PM. on August 26, 2015, in the Board Room on the 29<sup>th</sup> floor of 2 Peachtree Street.
